Objective:

The purpose of this consultancy is to:

Job Description

- Provide the needed technical support for its well-functioning.
- Review the existing MIS user guides for various databases and IM system and if needed revise the existing key SOPs for data flow process and user charts and accountabilities, if required.
- Provide technical support for DWCD GoUP various programmes/schemes to develop Information Management Systems for child protection system strengthening, alternative care, ending child marriage, gender based violence, violence against children, Mahila Shakti Kendra, One Stop Center and COVID-19 response related indicators for monitoring, tracking, analysis and reporting purposes in the context of the various response work plans and data gathering monitoring plans.
- Compile and validate, and undertake data cleaning for data disaggregation tables for all relevant sections for annual reporting
- Contribute to introducing and refining existing IM structures for the programme.
 Those include online real-time monitoring platforms; dashboard structures and analysis boards of databases- based on good regional/global practices.
- Compile/analyze monitoring and evaluation information/data, and make them available to DWCD and UNICEF, Office of Uttar Pradesh for different reporting requirements in coordination.

- Rolling out of MIS/CPMIS in at state and district level
- Undertake MIS capacity building to the Department and Implementing Partners of UNICEF on Information system development and reporting requirements and means of verification for sector dashboard, Sitrep/update and activity info and other reporting requirements on the process of data collection level and results reporting levels
- Review (validation of data coming from the districts) and follow-up for any suspicious or wrong data entry.
- Supporting monitoring of CP-related programmes- including real-time monitoring systems.
- Analysis of existing CPMIS data, preparing infographics, presentations for the government to use them.
- Evaluations, assessments, etc.
- Support any online assessments, post assessments and beneficiaries' feedbacks.
